Comes now JAMES EARL RAY, the defendant in the above styled cause, through his attorneys ~~_____~~, J. B. Stoner, Richard J. Ryan, and Robert W. Hill, Jr., and respectfully moves the Court:

To set aside his plea of guilty, to set aside his conviction, and grant him a new trial on the following:

1. He was ~~convicted~~ ^{IMPROPERLY MISLED INTO ENTERING} ~~and sentenced to life imprisonment~~ ^{A PLEA OF GUILTY} ~~although he was innocent~~ ^{of the crime} as evidenced by Exhibits 1, 2, 3, 4, 5, 6 and 7, attached.
