If during the 8:00 PM to 8:AM shift General Canale has to leave his residence one of the men on the night shift will accompany him and the other man will remain in the residence.

It is important that the man with General Canale during the day or night while he is away from his residence use the call number 43 and the number 42 is only used by the man at the residence.uses the radio.

It is especially important that these men be extremely alert and as courteous as possible in order that the Sheriff's Department will be regarded as a top notch Department by the many members of the news media who will be present.

The following men will be assigned to the security detail which will protect Judge Battle and his residence.

The deputies on the night shift will be alert ~~to~~ to any possibilities and pay particular attention to their actions so as not to cause any extra inconvenience to Judge Battle and his family.

There will be no deputy on duty from 6:00 A.M. to 8:00 A.M. as this will give the Judge and his family time to get up and eat and get ready to go to work.
