SCHEIBLER - FERRELL - WILLIAMSON FAMILY CEMETERY

Visited June 17, 1981. This cemetery is located on the property of Mr. James E. Scheibler, 4595 Billy Maher Road. Mr Scheibler's home is approached by a long winding drive, and the cemetery is located approximately half-way between the road and the home on the south side of the drive. Mr. Scheibler's parents are buried under a large magnolia tree.

CHRISTIAN FAMILY CEMETERY

Visited November 2, 1975. This small cemetery is located on the remaining farm property of Mrs. Joe Bursi, 4920 Winchester Road. Adjacent property has been developed into apartment complexes. Mrs. Bursi and her daughter, Miss Louise Bursi, told the compilers the property was part of 2000 acres owned by Fredrick Christian. The Bursi family is the third owner, having purchased the property from the LeMaster family in 1933. The mailing address of Mrs. and Miss Bursi is, P.O. Box 18005, Memphis, TN

38118. Mrs. Bursi said she was told that Robert Edward Christian was killed by lightning and the fall of a tree. She said Mrs. Grace Christian M. Warner visited the property in 1939 to see the cemetery and do other research in Shelby County. Her address at that time was 1602 L Street, Huntsville, Texas. Mrs Warner also gave Mrs. Bursi a small note with the following data: (Shelby County Deed)) "Book E, p.474 - 2000 acres. F. Christian to Jas. S. LeMaster - 300 acres reserving 1/2 acre where said Christian's wife and children are buried. 5th of Jan. 1837. 1883 divided." Miss Bursi said the present home was built in 1939, and the remains of an old home on the property were removed at that time. During the removal, a large newspaper-mud block (chinking?) was found with the date of December 1833. There are four stones in a row:

Shelby County Will Book I, pp. 329-330: Will of Frederick Christian.... my two beloved children Robert Edward Christian and Sally Ann Francis Christian all my Estate ... to be equally divided between them ... my brother Wyatt Christian sole executor ... to sell any part of my Estate ... for the use and benefit of my two children ... (dated) August 5, 1838. Witnesses: Jas. G. Mitchell, Abraham (his X mark) Booth, Joshua G. Dunday (sic), L.D. Irwin, W.P. Mathews. Proved August term 1845 (on oath of) Wm. P. Mathews, Silas D. Irwin and Boler Cocke, Abraham Booth - having since the time of signing said will departed this life ... and Jas. C/G. Mitchell and Joshua G. Lunday ... are both at this time out of the state. Recorded August 11th 1845.

Shelby County Will Book I, pp. 356-357: Will of Wyatt Christian. ... Estate which I have conjointly with my late brother Frederick Christian in Shelby County shall continue undivided with his ... until the marriage or death or the arrival at the age of 21 of my niece Sally Ann Francis Christian during which connection the said property shall be used for the joint interest ... of my wife and children and my said niece. ... my wife Mary Bailey Christian ... my daughter Mary Carver (now Mrs. Weld) ... my three children Mary Carver, Sally Francis and Caroline Wyatt ... William Mathews and James T. Leath the executors ... (dated) September 15, 1846. Witnesses: Wm. Park, H.L. Guion, I.W. Doyle. Proved October term 1846 (by prior witnesses.) Recorded March 12, 1847.

The Nashville Whig of Tuesday, Sept. 22, 1846, reported the death of Dr. Wyatt Christian "in Memphis on 15th inst."

In 1897, John Lenow copied the inscriptions from many of the then surviving tombstones in Winchester Cemetery. A list in the Memphis and Shelby County Board of Health shows the following:

HISTORY OF MEDICINE IN MEMPHIS, edited by Marcus J. Stewart, M.D., and William T. Black, M.D., in 1971, contains a biographical sketch of Wyatt Christian, 1798-1846: He came to Memphis in 1825 from Charles City, Virginia. He had received his M.D. degree from the University of Pennsylvania in 1821 and began practice in his native Charles City. In 1830, he became a charter member of the Medical Society of Tennessee. He was one of the first three physicians in Memphis. Wyatt was the only physician on the Board of Directors of Memphis Hospital from his appointment in 1838 until his death, and was also attending physician to the Memphis Hospital. As a public servant, he was Alderman in the 3rd corporate year of the City, March 1829 to March 1830. In those days, it was quite common for physicians to own and operate drug businesses, and, in 1836, he purchased a partnership in the firm of Booth and Tucker, creating the firm of Booth and Christian. By 1838 Booth had left the firm, but on January 15, 1839, Dr. Christian sold his entire stock of drugs to John Booth and Joseph Mallory.
